







### Terms of Reference (ToR)

Consultancy services for Comprehensive Business scoping study/Market Survey for processed drinking water and Sanitary Pad with detail Business Plan development and also explore other WASH related possible enterprises.

### 1. Background

Sabal Nepal in a partnership with Welthungerhilfe (WHH) is implementing "Up-scaling" WASH systems strengthening approach in the Terai region of Nepal (NPL 1082-22)" project in 5 Municipalities of Siraha District namely Siraha Municipality, Karjhana Municipality, Kalyanpur Municipality, Golbazar Municipality and Bishnupur RM since March 2023. The overall objective of the project is "promoting the availability and sustainable management of water and sanitation through community engagement, WASH systems strengthening and advocacy". The project is focus on development of WASH entrepreneurs typically revolves around creating sustainable business models that provide essential services and products related to water, sanitation, and hygiene. It is also focused on maximum utilization of Drinking water (after fulfilling the demand of users) and extra water as business perspective for generation of income of the groups like WSUCs, Total sanitation women groups with technical Assistance support by respective municipalities. In this regard, Karjanha Municipality has made a request for Technical Assistant support for detail technical study of Comprehensive Business scoping study/Market Survey for processed drinking water and Sanitary Pad, with detail Business Plan development and also explore other WASH related possible enterprises.

The ToR requires a qualified individual consultant/ consulting firm who has proven expertise on technical study of such Comprehensive Business scoping study/Market Survey for processed drinking water and Sanitary Pad and Business Plan development of both trade. The study is mainly focused on the business scoping

study- cost and benefit analysis for process bottled/jar water to be run by Water Sanitation Users Committee and to carry out the comprehensive market scoping study to establish the 100% bio-degradable sanitary pad production company by local people (Women Group/Cooperatives/Youth club/Water sanitation Users Committee) and also explore other WASH related possible enterprises.

## 2. Objective

The major objectives of the assignment are as follows:

- Conduct detail market research and analysis to understand the market status and market actors of Processed Water (Bottled or Jar) and Sanitary Pad also explore other WASH related possible enterprises.
- To understand the viability and recommend business model and both products to local community level MSMEs.
- To develop business plan of both product and develop implementation plan.
- 3. Scope of Work: The consultant will be responsible for
  - Desk Review
  - Review the relevant secondary information.
  - Detail action plan preparation.
  - Develop checklist/questionnaires for the survey and format for business plan and finalize in consultation with project personnel.
  - Conduct detail market survey (Customers, wholesalers, retailers, input suppliers, related entrepreneurs) in Siraha and Saptari districts
  - Data analysis and report preparation.
  - Develop business plan of both products.
- **4. Key Deliverables:** The Consultant will undertake the following duties and responsibilities.
  - A comprehensive Market Analysis report with recommendations for the suitable business model.
  - Develop a complete business plan of both products including (Market plan, production plan, expenses plan, financial plan, SWOT Analysis,

competitors' analysis, cash flow, Break Even Point (BEP), Return on Investment (ROI) and Internal Rate of Return (IRR)

Provide list of possible WASH related enterprises

### 5. Timeline of Assignment

The expected timeline for the assignment is 13- 15 days including final detail study report submission and presentation to the Municipality. The assignment period will be from 24 June to 24 July 2024.

# 6. Qualification/Expertise required within the study team:

To conduct a comprehensive business scoping study and develop the viable business plan of a processed drinking water to be supplied in the form of bottled or Jar and biodegradable Sanitary Pad to be run by a community group, following experts are required:

# I. Market Survey and Business Development Expert-1

- Sound knowledge in conducting Market research and analysis, understanding of market dynamics, customers and their purchasing behavior, Financial Analysis of the business and business modeling, cost benefit analysis, SWOT Analysis.
- Understanding of social business models and experience in designing business models that prioritize both financial sustainability and social impact.
- Understanding of value chain.
- Ability to develop innovative strategies for generating revenue while addressing social or environmental issues.
- Strong communication and presentation skills.
- Familiarity with the Water, Sanitation Hygiene (WASH) and WASH related business including relevant regulations, policies, and procedures related to enterprise development.
- Knowledge of environmental sustainability principles and practices related to water resource management and bottled water production.
- Master's degree in economics, business studies and similar level with experience of conducting at least 2 Market research and analysis and at least 8 viable Business Plans and similar types of study.
- Experience of developing Business plan and facilitation skills.
